Right For Kids: A project to do what is right for kids in state welfare systems by highlighting successful reforms in Florida that have dramatically reduced child abuse and the number of children languishing in state foster care, while greatly increasing the rate of children adopted out of foster care. Foundation staff worked in multiple states to educate policymakers and citizen leaders about how their states can replicate these reforms.

Stop the Scam: This project seeks to promote successful anti-fraud reforms in several states that removed thousands of ineligible recipients from welfare rolls, putting those individuals on a path to restore dignity and self-sufficiency and saving welfare dollars for those who truly need it. Foundation staff analyzed the results of these reforms, and shared their findings with state leaders across the county.
