This is the final response to the November 19, 2021, Freedom of Information Act (FOIA) request submitted to the U.S. Department of Agriculture (USDA), Departmental Administration (DA). The Office of Information Affairs (OIA), Freedom of Information Act (FOIA) Division is under the purview of the General Counsel (GC) and serves as the focal point for USDA's FOIA program. It provides coordination and ensures agency-wide compliance with the FOIA. Additionally, the OIA-FOIA processes requests and appeals on behalf of the Office of the Secretary (OSEC); the Under Secretaries; USDA's staff offices; and the Research, Education and Economics and Trade and Foreign Agricultural Affairs mission areas.

The request sought the following:

- 1) All electronic communications, briefs, papers, or analysis related to your agency's decision to abandon the cost-neutral policy it has followed for the past 45 years including those authored or submitted by the Chief Economist, or the staff of the Chief Economist.
- 2) All reports, memos, briefs, electronic communications, or other documents related to a review of the costs and legal implications of the 2021 Thrifty Food Plan completed by the USDA Office of the Chief Economist (OCE). This includes any documents outlining objections to either the increase in SNAP benefits or the abandonment of the cost neutral policy raised by the Office of the Chief Economist.
- 3) If the Office of the Chief Economist was not consulted before the 2021 Thrifty Food Plan was approved, please provide any documentation that would explain why they were not consulted and who made the decision to refuse to allow them to weigh in on the decision, if applicable. (Date Range for Record Search: From 1/22/2021 To 9/1/2021)

Your request has been processed under the FOIA, 5 U.S.C. § 552.

A search for responsive records was conducted by the OCE. The OCE's search did not locate any responsive records. Therefore, the OIA is unable to provide any records that are responsive
