

- Ensure parental rights in education

- Foster a business-friendly regulatory environment
- Waive taxes and fees on start-ups and occupational licenses
- Prevent and REIN in costly regulations
- Streamline permitting processes to expand housing and business development
- End participation in the disastrous \$300 weekly unemployment bonus
- Preempt local occupational licensing
- Provide statewide work or training requirement in food stamps
- Provide historic tax cuts
- Ban ESG ideology in state pension investments
